### Services of Allay Funeral Director, Staff, and Overhead | \$950

This fee is for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation. This fee includes coordinating all cremation arrangements; conducting the arrangement conference; obtaining the necessary authorization and permits; refrigeration; registering the death certificate in the county where passing occurred; preparing and filing required notices and obtaining certified copies of the death certificate on your behalf.
